#### **Old Business**

## **Painting**

Luis, Nelson and Oscar will be doing the painting. Building 37 has been completed other than the doors. Luis thinks they can complete a building in 1 week. The cost of the equipment and time will be tracked on the first three buildings to get an average of the time and cost per building. Building 7 and 5 are the next to be started.

### **Fences**

Homeowners, whose fences are in need of replacement, will be informed, diplomatically that they are not in compliance with the Deed Restrictions. If they do not renew their fence, we will and they will be billed accordingly. A request will be made to remove any decorations inhibiting the painting of garages, doors etc. If not removed we cannot be held liable for any damage.

Back doors will be painted and homeowners who are not home to open doors will be responsible for painting the edge.

#### **Gutters**

Linda Braccio made a motion to readdress gutters, Linda Leuders seconded.

Luis wants them down because of the damage they cause and the constant work involved in keeping them clean.

Carrie informed us that 4 people in Building 37 wanted their gutters and they were left on.
